- 1. The selection shall be on academic arrangement basis initially for a period of one year extendable upto maximum of six years (one year at a time and subject to good work & conduct) or till the selection/promotion is made in accordance with the Rules of Recruitment governing these posts, whichever is earlier.
- 2. The selection on academic arrangement basis shall by itself stand terminated on the attainment of 65 years of age by the selected candidate.
