Applications are invited to fulfill the shortcomings raised by National Commission for Indian System of medicine, GoI vide No. 26-75/2021/Ay (visitation), dated 18-10-2021 from eligible candidates for engagement on "Academic Arrangement basis" under S.O-364, dated 27-11-2020, for below mentioned posts, initially for a period of one year extendable up to maximum of six years (one year at a time and subject to good performance and conduct) or till the selection is made in accordance with rules of recruitment rules governing the respective posts, whichever is earlier. **Essential Qualifications:**

**A. For the post of Medical Officer:**

A Bachelors degree in Ayurvedic Medicine from a University or its equivalent as recognized under the Indian Medicine Central Council Act, 1970. Preference will be given to the candidates having Post Graduate degree in the respective clinical subjects.

**B. For the post of Emergency Medical Officer:**

A Bachelors degree in Ayurvedic Medicine from a University or its equivalent as recognized under the Indian Medicine Central Council Act, 1970.

**C. For the post of Clinical Registrar/MO:**

A Bachelors degree in Ayurvedic Medicine from a University or its equivalent as recognized under the Indian Medicine Central Council Act, 1970.

Salary and age shall be as per SO-364 of 2020, dated 27-11-2020.

The selection criteria shall be strictly as per S.O-364 of 2020, dated 27-11-2020

**Criteria for Screening:**

- Academic Qualification (BAMS passed all examination at the first attempt) = 40 marks.
  - For each attempt 03 marks shall be deducted.
  - Distinction/Scholarship/Honours/Medals and certificate (up to maximum of 05 marks).
  - House Job experience in a teaching institution = 05 marks.
  - Experience certificate = 05 marks (Medical Officer (non PSC) under NHM/NAM or other scheme of GoI, minimum on year experience shall be considered for giving marks. One year = 01 marks.
  - Postgraduate Degree in concerned subject (Maximum 15 marks).
  - Professional Publication in a standard Medical Indexed Journal (02 marks for each) = 10 marks.
- Pre Award Roll Merit – out of 80 & Viva Voce – out of 20 points by the Committee members.  
Total - 100 points.

1. BAMS Degree/Marks Certificate (Aggregate).
2. Attempt certificate of all examinations of BAMS or any other qualification issued by the university.
3. Post Graduation degree in concerned discipline from NCISM/CCIM recognized institution.
4. Registration Certificate from J&K Board of Ayurvedic/Unani/Sowa Rigpa, Yoga & Naturopathy systems of Medicine.
5. Date of Birth Certificate.
6. Domicile Certificate.
7. Experience certificate if any.
8. Category Certificate (updated).
9. An affidavit duly attested by 1st Class Magistrate that the candidate is not in active Govt. Service.

The selection of the candidates for the posts shall be made by the Committee constituted by the Government.


