Sub: Matter related to grant of conditional permission to the Government Ayurvedic Medical College, Akhnoor, Jammu, Jammu & Kashmir with 50 seats in BAMS (UG) course under Section 13C/13A of the IMCC Act, 1970 for the academic session 2018-19—reg.

Sir,

I am directed to refer to the Ministry's order No. F.No.R.12011/41/2016-EP (IM-1) dated 15.09.2017 related to admission matter for the year 2017-18 intimating certain shortcomings for rectification for consideration of the case for the academic session 2018-19.

- 2. The CCIM had carried out an inspection of the institution on 18-19.05.2018 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry. On examining in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard of Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the IMCC Act, 1970, relevant regulations, several shortcoming were found. However, the CCIM has recommended for granting conditional permission for admission with 50 seats in BAMS (UG) course for the academic session 2018-19 subject to furnishing of undertaking from Secretary/Director/Commissioner of the Department of AYUSH/ISM of the State Government with an assurance that they will remove the shortcomings within three months.
- 3. After receiving of undertaking vide no. HD/ISM/108/2017 dated 21.08.2018 submitted by the Principal Secretary to the Government, Health & Medical Education Department, Civil Secretariat, Srinagar to the Ministry of AYUSH, New Delhi. It has, therefore, been decided to grant conditional permission to the Government Ayurvedic Medical College, Akhnoor, Jammu, Jammu & Kashmir with 50 seats in BAMS (UG) course for the academic session 2018-19 under section 13C/13A of the IMCC Act, 1970 subject to rectification of the following deficiencies within three months as undertaken by the State Government;

i. College Website is not functional as per RMS.

- ii. Undertaking regarding Aadhar enabled GPS tagged biometric Attendance System (AGBAS) has not been submitted.
- iii. Demonstration room and teaching pharmacy are not available.
- iv. Area of herbal garden is 2000 Sq. Mt. against the minimum requirement of 2500 Sq. mt.
- v. Subdivided area of College building among various component is not available as per RMS.

vi. Teaching Staff:-

- 1. Availability of teaching staff is 7 against the minimum requirement of 12 for conditional permission.
- 2. There is no Sanskrit teacher in the Dept. of Ayurved Samhita & Siddhant against the minimum requirement of 01.
- 3. There is no Higher and Lower Faculty available in the department of Dravyaguna, Rasashastra & Bhaishajya Kalpana against the minimum requirement of 01 in each.
- 4. There is no higher faculty available in the department of Ayurveda Samhita & Siddant and Rognidan against the minimum requirement of 01.

vii. Non-Teaching Staff:-

- Availability of Non-teaching staff is 4 against the Minimum requirement of 17 for conditional permission.
- 2. There is no librarian, Assistant librarian and Library Attendant or Peon in Library against the minimum requirement of 01 each.
- 3. There is no attendant in the department of Samhita and Siddhant against the minimum requirement of 01.
- 4. There is no Laboratory technician, Museum Keeper and lifter in the department t of Rachna Sharir against the minimum requirement of 01 for each.
- 5. There is no Laboratory technician in the department of Kriya Sharir against the minimum requirement of 01.
- 6. There is Laboratory technician and Museum keeper in the department of Dravyaguna against the minimum requirement of 01 in each.
- 7. There is Laboratory Technician and Laboratory Assistant in the department of Rasashastra Evum Bhaishajya Kalpana against the minimum requirement of 01 in each.
- 8. There is 01 Laboratory Technician in the department of Rog Nidan against the minimum requirement of 02.
- 9. There is no gardener and multipurpose workers in herbal garden against the minimum requirement of 01 and 02 respectively.

viii. Funcationality of Hospital:-

- 1. Computerized Central Registration is not available for ODP and IPD.
- 2. Total number of patients attended OPD from 1st Jan. 2017 to 31st Dec. 2017 are 35281 against the minimum requirement of 36000.
- 3. Average attendance of patient in OPD per day is 117.60 against the minimum requirement of 120 as per RMS.
- 4. Total no. of beds available is 47 against the minimum requirement of 60 as per RMS.
- 5. Labour room is non-functional as per RMS.
- 6. Clinical Laboratory, X-Ray, ECG and USG are not available as per RMS.

- **16.** There is no Analytical Chemist and Pharmacognosist available in Teaching Pharmacy and Quality testing laboratory against the minimum requirement of 01 each.

- 4. The College is also directed that the following requirements should be fulfilled by the college positively by the 31st December, 2018, which will be verified for granting permission from the academic session 2019-2020 onwards:
 - (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016 by 31st December 2018 to get conditional permission.
 - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
 - (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled in toto.
