
**The selection is strictly governed by the following terms and conditions of S.O-364, dated 27-11-2020.**

1. The selected candidate is directed to report to the Principal, Govt. Ayurvedic Medical College Akhnoor, within a period of twenty one (21) days, from the date of the issuance of this order on the production of below mentioned certificates and testimonials in original, failing which their engagement as such shall stand cancelled without any further notice.
  - a) Academic Qualification and Technical Qualification.
  - b) Date of Birth Certificate.
  - c) Health Certificate from the concerned Chief Medical Officer of the District.
  - d) Domicile Certificate.
  - e) Character Certificate duly issued by the concerned Police Station/SHO.
  - f) Relevant Category Certificate (if any).

2. The selected candidates shall have to execute an agreement with the Government on the prescribed Form appended as Form "A" to S.O 364 of 2020 dated 27-11-2020. The selection shall be on academic arrangement basis initially for a period of one year extendable up to maximum of six years (one year at a time and subject to good work & conduct) or till the selection/promotion is made in accordance with the Rules of Recruitment governing the posts, whichever is earlier.
3. The services of selected candidates shall be terminable before the expiry of the tenure of appointment with one month's notice by appointing authority.
4. The selected candidates shall be paid consolidated pay equal to the revised basic pay as mentioned in S.O 364 of 2020, dated 27-11-2020.
5. The selected candidate shall not be entitled to any other additional monetary benefit, what so ever except of House Rent Allowance (HRA) as applicable to in-service candidate carrying the minimum of the pre-revised scale of the post subject to fulfilment of the conditions provided under the relevant rules in this regard.
6. In matter of discipline and conduct, the selected candidate shall be governed by the rules, regulations and orders in vogue in the Civil Services Rules on the subject.
7. Any residuary matter shall be governed by the S.O-364, dated 27-11-2020.
8. The salary shall be released after receiving satisfactory verification of character and antecedent from Criminal Investigation Department, J&K & verification of Diploma/Degrees/other relevant documents from the concern issuing authority.
