

The selection is strictly governed by the following terms and conditions of S.O-364, dated 27-11-2020.

1. The selection shall be on academic arrangement basis, initially for a period of one year extendable up to maximum of six years (one year at a time and subject to good work & conduct) or till the selection/promotion is made in accordance with the Rules of Recruitment governing these posts, whichever is earlier.
2. The selection on academic arrangement basis shall by itself stand terminated on the attainment of 65 years of age by the selected candidate.

3. That the appointment on Academic arrangement basis of the appointee shall be terminable on either side by prior notice of one month or on payment of one month's salary by the appointing authority.
4. The selected candidates shall have to execute an agreement with the Government on the prescribed form appended as Form "A" to S.O 364 of 2020, dated 27-11-2020.
5. The selected candidates shall be paid consolidated pay equal to the revised basic pay as mentioned in S.O 364 of 2020, dated 27-11-2020.
6. The selected candidate shall not be entitled to any other additional monetary benefit, what so ever except of House Rent Allowance (HRA) as applicable to in-service candidate carrying minimum of the pre-revised scale of the post subject to fulfilment of the conditions provided under the relevant rules in this regard.
7. In matter of discipline and conduct, the selected candidate shall be governed by the rules, regulations and orders in vogue in the Civil Services Rules on the subject.
8. Any residuary matter shall be governed by the S.O-364, dated 27-11-2020.
9. The order is issued subject to the outcome of any writ petition(s) pending in any court of law.
 1. The selected candidates are directed to report to the Principal, Govt. Ayurvedic Medical College Akhnoor within a period of 07 days from the date of the issuance of this order along with the CID verification forms (in triplicate) and after receiving satisfactory verification of character and antecedent from CID & verification of relevant documents from the concern issuing authority. The candidate will be allowed to join on the production of below mentioned certificates and testimonials in original, failing which their selection shall be deemed to have been cancelled *ab-initio* & wait list will be operated.
