To fulfill shortfall raised by National Commission for Indian System of Medicine (NCISM), GoI, applications are invited from the eligible candidates for engagement on "Academic Arrangement Basis" under S.O-364, dated 27-11-2020 for below mentioned post, initially for a period of one year extendable up to maximum of six years (one year at a time and subject to good performance and conduct) or till the selection is made in accordance with rules of recruitment rules governing the said post, whichever is earlier. The extension so granted under these rules shall not be beyond a period of six years under any circumstances. The details of post is as under:

Salary, age & terms shall be as per S.O – 364 of 2020, dated 27-11-2020.

2. Graduation Degree & Marks Certificate (Aggregate).
3. Post Graduation degree in concerned discipline.
4. Registration Certificate from J&K Board of Ayuvedic/Unani/Sowa Rigpa, Yoga & Naturopathy systems of Medicine.
5. Date of Birth Certificate.
6. Domicile Certificate.
7. Unique Teacher Code allotted by NCISM or NTET qualified certificate.
8. Experience certificate with NCISM Teacher Code, if any.
9. An affidavit duly attested by 1st Class Magistrate that the candidate is not in active Govt. Service.

The selection of the candidates for the post shall be made by the Committee as per selection criteria issued by the Govt. vide No. 554-JK (HME) of 2023, dated 11-07-2023. (copy enclosed)

The Appointment against the advertised posts shall and shall be purely on Academic arrangement basis only without conferment of any preferential right of engages for regular appointment against these posts, which shall strictly be made in accordance with the relevant recruitment rules. The service of the appointee under these rules shall be terminable before the expiry of the tenure of appointment with one month's notice from either side or on payment of one month's salary in lieu of notice by the appointing authority.

WHEREAS, Rule 6 of the Jammu & Kashmir Medical & Dental Education (Appointment on Academic Arrangement Basis), Rules, 2020 notified vide SO 364 of 2020 dated 27.11.2020 provides as under:

Selection Committee: (1) The selection of the candidates for the posts of teaching faculty in Medical/Dental/Ayurvedic/Unani Colleges and for the posts of Medical Officers shall be made by a Selection Committee comprising:

1	Administrative Secretary, Health & Medical Education Department	Chairman
2	Principal of the concerned Government Medical College/Dental College/Ayurvedic College/Unani College (as the case may be)	Member
3	HoD of the concerned discipline (not below the rank of Professor) in the concerned Medical College/Dental College & Director ISM in case of Ayurvedic College/Unani College. (In case of GMCs Anantnag, Baramulla, Handwara, HoD of the concerned discipline in GMC, Srinagar and in case of GMCs Doda, Kathua, Rajouri & Udhampur, HoD of the concerned discipline in GMC, Jammu shall be the members till such time the faculty of the appropriate level is in position in these new Medical Colleges).	Member
4	One expert in the relevant discipline to be nominated by the Government	Member

AND WHEREAS, In the Jammu & Kashmir Medical & Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, the selection criteria for engagement on faculty posts and Medical Officers in Government Ayurvedic & Unani Medical Colleges have not been prescribed;

AND WHEREAS, the H&ME Department vide Government Order No. 282-JK(HME) of 2023 dated 04.04.2023 adopted uniform selection criteria for engagement of faculty under SO 364 of 2020 dated 27.11.2020 and Registrars/ Demonstrators/ Tutors in all Government Medical Colleges and Government Dental Colleges of J&K. This necessitated adoption of uniform criteria in Government Ayurvedic & Unani Medical Colleges of J&K.

AND WHEREAS, the case was examined in the Department, accordingly, a Committee of PG Medical Officers of Ayurvedic/Unani was constituted to prepare the selection criteria for engagement of faculty and Medical Officers in Government Ayurvedic & Unani Medical Colleges on academic arrangement basis;

AND WHEREAS, the proposed selection criteria were examined in the H&ME Department in reference to the recruitment rules of Government Ayurvedic and Unani Medical Colleges of J&K;

Now, therefore, uniform selection criteria for engagement of various faculty posts viz. Associate Professor & Assistant Professor and Medical Officer in terms of the Jammu & Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020 notified vide SO 364 of 2020 dated 27.11.2020 in Government Ayurvedic Medical College and Government Unani Medical Colleges of J&K, forming **Annexure-A & B** to this Government Order, are hereby issued with immediate effect.
