ID AYU0476) to start 07 new PG degree programme with 32 Seats (instead of 35 seats) in the subject namely :- (i) Ayurved Samhita, Sanskrit & Siddhanta-05 seats (ii) Kriya Sharir-05 seats (iii) Rachna Sharir-05 seats, (iv) Kayachikitsa-05 seats (v) Panchakarma- 03 seats (instead of 05 seats) (vi) Shalya Tantra - 04 seats (instead of 05 seats) and (vii) Kaumarbhritya-Bala Roga- 05 seats under section 29 of NCISM Act, 2020 from the academic session 2025-26-reg.

Sir/Madam,

- 1) I am to refer to your application/scheme vide Ref. No. GAMC/PS/1127-1130 dated 29.07.2024 on the subject cited above and to verify the available facilities of teaching, non-teaching, hospital staff and other facilities available at your college namely Government Ayurvedic Medical College, Teh. Akhnoor, Village- Sangani, Jammu-181201 Jammu & Kashmir (Inst. ID AYU0476) your college was visited on 21.07.2025 & 22.07.2025 for issuance of LOI and accordingly Letter of Intent (LOI) was issued to you vide letter of even no. dated 04.09.2025 to start 07 New PG degree programme with 35 seats in the subject namely :- (i) Ayurved Samhita, Sanskrit & Siddhanta-05 seats (ii) Kriya Sharir-05 seats (iii) Rachna Sharir-05 seats, (iv) Kayachikitsa-05 seats (v) Panchkarma- 05 seats (vi) Shalya Tantra - 05 seats and (vii) Kaumarbhritya-Bala Roga- 05 seats, under section 29 of NCISM Act 2020 from the academic session 2025-26.
- 2) The Medical Assessment and Rating Board for Indian System of Medicine (NCISM) had carried out an inspection of the college again on 22.09.2025 & 23.09.2025 through Hybrid mode to assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities available as a part of annual visitation to start 07 New PG degree programme with 35 seats in the subject namely :- (i) Ayurved Samhita, Sanskrit & Siddhanta-05 seats (ii) Kriya Sharir-05 seats (iii) Rachna Sharir-05 seats, (iv) Kayachikitsa-05 seats (v) Panchkarma- 05 seats (vi) Shalya Tantra - 05 seats and (vii) Kaumarbhritya-Bala Roga- 05 seats, under section 29 of NCISM Act, 2020 from the academic session 2025-26.
- 3) The visitation report and all other related documents were assessed in terms of enforced regulations namely the MESAR PG Ayurveda 2024, and provisions under the NCISM Act, 2020 and relevant regulations thereunder. On careful examination of the assessment report and as per the Visitor Observation following shortcomings/defects have been observed:-

1. Hospital staffs: -

a) Availability of hospital staff is $\frac{\text{Available}}{\text{Required}} \times 100\% = \frac{78}{85} \times 100\% = 91.7\%$.

a) Shortcoming is as under-

2. Functionality of the hospital:-

a) Average bed occupancy percentage is 40.13%. **Shortcomings is 9.869**

3. Mean of general and essential equipment's/instruments availability is 94.99%.

- 4) The assessment report was duly placed in the 149th Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) convened on 07.10.2025 and Board decided that college is fulfilling the eligibility criteria for issuance of permission in 07 PG Courses with 32 seats (instead of 35 seats) in the subject namely :- (i) Ayurved Samhita, Sanskrit & Siddhanta-05 seats (ii) Kriya Sharir-05 seats (iii) Rachna Sharir-05 seats, (iv) Kayachikitsa-05 seats (v) Panchkarma- 03 seats (instead of 05 seats as only 01 LF have more than 05 year of experience) (vi) Shalya Tantra – 04 seats (instead of 05 seats as only 02 LF have more than 05 year of experience) and (vii) Kaumarbhritya-Bala Roga- 05 seats, under section 29 of NCISM Act, 2020 from the academic session 2025-26.

"DECISION"

- 5) Therefore, Government Ayurvedic Medical College, Teh. Akhnoor, Village- Sangani, Jammu-181201 Jammu & Kashmir (Inst. ID AYU0476) is hereby issued with Letter of Permission to start 07 New PG degree programme with 32 seats (instead of 35 seats) in the subject namely (i) Ayurved Samhita, Sanskrit & Siddhanta-05 seats (ii) Kriya Sharir-05 seats (iii) Rachna Sharir-05 seats, (iv) Kayachikitsa-05 seats (v) Panchkarma- 03 seats (instead of 05 seats as only 01 LF have more than 05 year of experience) (vi) Shalya Tantra – 04 seats (instead of 05 seats as only 02 LF have more than 05 year of experience) and (vii) Kaumarbhritya-Bala Roga- 05 seats in accordance of regulation 43 (4) of MESAR PG Ayurveda from the academic session 2025-26, under section 29 of NCISM Act, 2020 subject to the condition that aforementioned shortcoming shall be fulfilled along with the following conditions:
- It is further informed that **minimum 15% of postgraduate seats of the permitted intake capacity with 32 seats (instead of 35 seats) in 07 PG courses shall** be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2025-26 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
- 6) Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
- 7) Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stop page of admission for that particular academic year or the subsequent year.
- 8) Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- 9) **Compliance of all the requirements of Aadhaar Enabled Biometric Attendance System as mentioned in the Implementation letters vide. ref. no. 3/2024/MARB/AEBAS & HMS. Dated 09.05.2024 & 06.09.2024 issued by the Board.**
- 10) **The following requirements must be fulfilled and the compliance report must reach the Board by 31st December, 2025 to be considered for the issuance of permission for the academic session 2026-2027:-**
- All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto.
 - All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in NCISM (Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda) Regulations, 2024.
 - The shortcoming mentioned in point no 3.
- 11) **This permission to start 07 New PG degree programme with 32 Seats (instead of 35 seats) in the subject namely :- (i) Ayurved Samhita, Sanskrit & Siddhanta-05 seats (ii) Kriya Sharir-05 seats (iii) Rachna Sharir-05 seats, (iv) Kayachikitsa-05 seats (v) Panchkarma- 03 seats (instead of 05 seats) (vi) Shalya Tantra – 04 seats (instead of 05 seats) and (vii) Kaumarbhritya-Bala Roga- 05 seats from the academic session 2025-26 as stated above for**

the first admitted batch of 2025-26 session, will be valid till such time as the first batch of students admitted against these courses appear for the first final examination of the said courses and at that time, the College authorities may take up the matter for recognition of the qualifications under Section 35 of the NCISM Act 2020.

- 12) The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2026-27.
